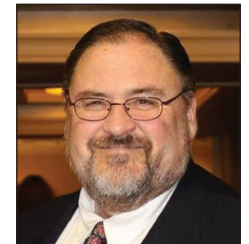

## Description of Bills

**The Women's Right to Know Act** would restore informed consent to mothers who meet the requirements to have an abortion in West Virginia, by requiring that they be informed about the risks of, and alternatives to, abortion. It would educate patients regarding the dangers of the abortion pill, along with the fact that the effects of such a chemical abortion can be reversed. It would also ensure that information on disabilities (including support networks) is given to parents when they are told that their unborn child has special needs.

**The Assisted Suicide Prevention Act** would make encouraging or aiding with the suicide of any person *by any person* (not just health care personnel) a felony. Furthermore, prescribing a lethal dose of medication by a health practitioner would be addressed by civil and licensure relief, including the award of attorney's fees and damages.
